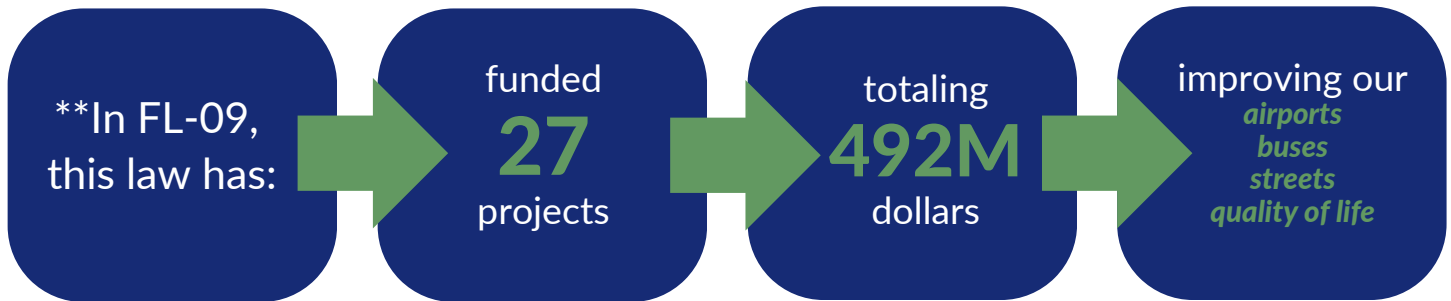


INFRASTRUCTURE LAW FUNDING IN FL-09

After decades of talk on rebuilding America's crumbling infrastructure, President Biden and Congress delivered the **Infrastructure Law** – a historic investment in America that will change people's lives for the better and get America moving again. To date, this law has funded over 20,000 projects nationwide and there are more to come.

Federal Aviation Administration: \$208.6M

Airport Terminal Program (ATP)

- **Orlando International Airport: \$50M Airport Terminal Program (FY22)**
 - MCO received \$50 million to start phase 1 of Terminal C expansion and construct 4 additional gates with 8 loading bridges.
- **Orlando International Airport: \$69M Airport Terminal Program (FY23)**
 - MCO will receive \$49 million to build four additional multiple aircraft ramp system (MARS) gates at Terminal C and \$20 million for the Terminal C multi-modal connector pedestrian bridge project.



Airport Infrastructure Grant (AIG)

- **Orlando International Airport: \$44M Airport Infrastructure Grant (FY22)**
- **Kissimmee Gateway Authority: \$763K Airport Infrastructure Grant (FY22)**
- **Kissimmee Gateway Authority: \$844K Airport Infrastructure Grant (FY23)**
- **Orlando International Airport: \$43.8M Airport Infrastructure Grant (FY23)**

Federal Transit Administration: \$16.1M

- **LYNX: \$16.1M Low or No Emission (Bus) Grants**
 - To buy battery electric buses and equipment to replace diesel and gas vehicles. The new electric vehicles will reduce carbon emissions and support LYNX's plans to transition its fleet to low or zero-emission vehicles by 2028.

Office of the Secretary: \$19.5M

- **MetroPlan Orlando: \$3.79M Safe Streets and Roads Grant**
 - To develop Vision Zero Safety Action Plans throughout Orange, Osceola, and Seminole counties – working toward the ultimate goal of zero deaths and serious injuries on the region's roads.
- **I-4 West Central Florida Truck Parking Facility: \$16M INFRA Grant**
 - To tackle the shortage of commercial truck parking on a corridor between Tampa and Orlando by constructing a new truck parking facility with approximately 120 spaces, electric charging stations, and pedestrian infrastructure.
- **Polk County: \$720K Safe Streets and Roads Grant**
 - To develop Vision Zero Action Plan to reach the target of zero fatalities countywide.



Federal Highway Authority: \$247.8M

- **Orange and Osceola County Highways: \$224.8M National Highway Performance Program Grant**
 - To provide support for the condition and performance of national highways, invest in highway construction and increase highway resiliency for extreme weather events and natural disasters.
- **Orange and Osceola County Infrastructure: \$16.8M Surface Transportation Block Grant Program**
 - To improve the conditions and performance on any federal-aid highway, bridge and tunnel project on any public road, pedestrian and bicycle infrastructure, and transit capital projects such as intercity bus terminals.
- **Orange and Polk Counties MetroPlan : \$4.9M Metropolitan Planning Grant**
 - To make transportation investment decisions in the metropolitan areas.
- **Osceola County Highway Safety: \$1.2M Highway Safety Improvement Grant**
 - To reduce traffic fatalities and serious injuries on all public roads.
